M1 junction 13 to 16 smart motorway programme

I am writing to update you on the progress of the above scheme.

We will be carrying out overnight closures to remove trees from the verge in the dormouse sensitive area. Due to ecological constraints, we are unable to put any equipment or vehicles on the verge. We are also prevented from felling trees and allowing them to drop onto the ground. It is therefore necessary to use specialist machinery with the capability of cutting and lifting trees away from the verge and them chipping into adjacent vehicles.

In addition to this work we will be extending the temporary traffic management to junction 15. Safety is our number one priority and for this reason work of this type must be carried out using a full carriageway closure.

Therefore, as part of these works we will be carrying out overnight closures as detailed in the schedule overleaf. Please note these are provisional dates, and are subject to change, as there may be network conditions outside of our control; such as adverse weather, and incidents on the network. Drivers are asked to follow the signed diversion routes during these closures. Please do not use satellite navigation (sat nav) when following the diversion, as they may give conflicting information. Please refer to our website for the strategic diversion routes.

We advise local residents and business owners to ensure they allow extra time to complete their journeys. We will do our utmost to complete the work as quickly as possible and keep noise and disruption to a minimum. However, we acknowledge some operations may cause noise, for example reversing bleepers which have to be operational on our vehicles for health and safety reasons.
